By – Laws of Laurel Lodge #237 F. & A.M Laurel Springs, N.J. Constituted May 22,1922[Type here]

Constituted by and under the authority of a warrant issued by the Most Ancient and Honorable Society of Free and Accepted Masons for the State of New Jersey on the 20th day of April, AD 1922, AL 5922

Article 1 - Communications

The regular Communication of this Lodge shall be held on the first and third Friday of each month except during the month of July and August and on the third Friday of December. If the first Friday of January falls on the first of the month (New Years Day) there will be no Communication. The Regular Communication shall begin at 7:45 PM. The Worshipful Master may, at his discretion, open a Regular Communication up to one hour earlier than the prescribed time provided that due and timely notice shall be given to every member and that no business shall be transacted until the regular hour stated above.

The Annual Communication of the Lodge shall occur at the first regular meeting in December at which time the election of Officers shall occur and all final Committee reports will be due for the past year.

The Annual Installation of Officers of the Lodge shall take place at an Emergent Communication on the third Friday or Saturday of December at the discretion of the Lodge.

Article 2 Officers

Section 1. The Elected Officers of this Lodge shall consist of the Worshipful Master, a Senior Warden, a Junior Warden, a Treasurer.and a Secretary. There shall also be elected at this Communication, a proxy to the Grand Lodge.

Section 2. The appointed Officers shall consist of Senior and Junior Deacons, Senior and Junior Masters of Ceremonies, Senior and Junior Stewards, Chaplin, Marshal, Organist, Tyler and a Historian, all of whom shall be appointed by the Worshipful Master on the evening of the Annual Election or Installation of Officers.

Section 3. There shall be a Treasurer elected at the Annual Communication of the Lodge each December. It shall be the duty of the Treasurer to deposit all money received by him, from the Secretary, giving a receipt for the same, into a depository designated by the Lodge, upon notice by the Secretary and approval of the Lodge. He shall pay all bills, debts upon approval of the Lodge and consent of the Worshipful Master. He shall post, in the Trestleboard, in February, a financial summery of the previous year. He shall pay over, to his successor in office, all money on hand and transfer his books and other property belonging to the Lodge within ten days after the expiration of his term of office. For his services to the Lodge, he shall receive the sum of two dollars (\$2.00) per member to be paid annually.

Section 4. There shall be a Secretary elected at the Annual Communication of the Lodge each December. It shall be the duty of the Secretary to notify candidate of their election or rejection, assign Investigation Committees, with the consent of the Worshipful Master, to process criminal background investigations of all Candidates for Election and Initiation, to render bills for annual dues, issue annual dues cards as required, to collect and carefully record the receipts of all monies and pay the same without delay to the Treasurer and perform such other duties pertaining to his office as the Worshipful Master may direct including the production, printing, mailing and e-mailing of the Lodges monthly Trestleboard, submission of the monthly reports and year end annual report to the Grand Lodge on time. Upon the expiration of his term of office, he shall submit, to his successor, all properties of the Lodge in his possession. For the faithful discharge of his duties the Secretary shall receive the sum of four dollars (\$4.00) per member to be paid annually.

Section 4a. The Lodge shall pay the cost of admission for the Worshipful Master and his wife or girlfriend to attend the Feast of St. John, the Chairman's Ball and the Grand Master's and Junior Grand Warden's receptions.

Section 4b. The Lodge shall pay the cost of hotel room expenses for the Worshipful Master, Senior and Junior Wardens, Secretary and the Proxy to Grand Lodge at the Annual Communication of the Most Worshipful Grand Lodge each year. If a lunch is scheduled immediately following the close of Grand Lodge Communication, the Lodge will pay the cost of the food only.

Section 5. There shall be a Board of Building Trustees consisting of six members. Each year two (2) Trustees shall be elected at the Annual Communication to serve a term of three (3) years. It shall be their duty to care for, preserve and maintain the property of the Lodge. The Building Trustees shall prepare and submit a proposed budget for the ensuing Masonic Year at the first Regular Communication in February for approval of the Lodge. They may from time to time, request additional funding from the Lodge should the need arise. The Building Trustees shall elect a Head Trustee each year in January. They will meet quarterly, keep written minutes of meetings, take attendance and provide a copy of said minutes to the Worshipful Master who shall see that they are read at a Regular Communication. The meeting date and time must be in the Trestleboard so any member may attend. Regular members may have a voice, at the discretion of the head Trustee, but no vote at the meeting. Board members must attend two (2) meetings per year.

Section 6. There shall be a Board of Financial Trustees consisting of three (3) members. Each year one (1) Trustee shall be elected at the Annual Communication to serve a Three (3) year term. The Board of Financial Trustees shall be responsible procure and maintain adequate insurance for the property and furniture of the Lodge. They shall also secure and maintain a safety deposit box at the same bank used by the Lodge. The

By – Laws of Laurel Lodge #237 F. & A.M Laurel Springs, N.J. Constituted May 22,1922[Type here]

Trustees will confirm with the Lodge Secretary that it is paid for at least one (1) year in advance each calendar year. Copies of all documents that go in to it shall be given to the Secretary for record keeping purposes. Furthermore, the Trustees shall see to it that all important documents including but not limited to the deeds, titles, stocks and bond certificates, insurance policies, Past Masters Jewels and other valuables be kept in an adequately sized box. An inventory shall be given to the Secretary annually by the first meeting in February. The Board of Financial Trustees shall elect a Head Trustee each year in January. It shall be the duty of the Head Trustee to have the signatures changed each year as needed and keys passed on to the appropriate members. The Board of Financial Trustee shall have charge of all investments ordered to be made by the Lodge and in the name of the Lodge and provided such funds are to be invested in such stocks, bonds or public securities as those in which savings banks or fiduciary institutions of the State of New Jersey may lawfully invest funds; but provided no loans or investments shall be made on real estate mortgage. When investments are made, the same shall not be altered or transferred without the consent of the Lodge given at a regular Communication of which said proposal each member shall have one (1) week's notice if possible. The Financial Trustee's will meet quarterly, keep written minutes of meetings, take attendance and provide a copy of said minutes to the Worshifull Master who shall see that they are read at a Regular Communication. The meeting date and time be in the Trestleboard so any member mat attend. Regular members may have a voice, at the discretion of the Head Trustee, but no vote at that meeting. Board members must attend two (2) meetings per year. The Financial Trustee's shall give a detailed report of the state of the invested funds and the income derived therefore at the first regular meeting in February.

Section 7. In the event of a vacancy on either board (Building or Financial) created by death, resignation or removal otherwise, the vacancy shall be by the appointment of a Brother by the Worshipful Master until the next Annual Communication when an election shall be held to fill the unexpired term so vacated.

Article 3 Fees and Dues

Section 1. The initiation fee shall be determined by consent of the Lodge and may be periodically increased as per the recommendation of the Financial Trustee's. 30% of the initiation fee shall accompany each Candidate's petition. The balance shall be payable prior to his initiation. There shall also be paid by each Candidate prior to his initiation, such sum as the Grand Lodge shall determine from time to time, as an initial contribution to charity.

Section 2. Should the petition of an applicant be rejected, he cannot renew his petition within three (3) months of such rejection. The initial payment of 30% of the initiation fee is not refundable in the event of such rejection and is only due upon his initial application.

Section 3. The annual Lodge dues for each member shall be an amount voted on by the membership in September, plus any or all fees for charitable purposes otherwise as shall be determined from time to time by the Most Worshipful Grand Lodge, payable in advance on or before December 31st each year.

Section 4. Any member who shall be twelve (12) months in arrears for dues and shall not have paid his annual dues in accordance with the provisions of the preceding section shall be notified by the Secretary, who shall under the seal of the Lodge, demand payment of the same by certified mail. If after the expiration of three (3) months from the date of such formal notice and demand, report the fact to the Lodge for action under the fourteenth (14*) General Regulation of the Most Worshipful Grand Lodge.

Section 5. Any who is seventy five (75) years old or older and has paid dues for forty (40) consecutive years to Laurel Lodge, shall be exempt from all future payments of all dues. The Brother may voluntary remit such sums as are required by the Grand Lodge so as to relieve Laurel Lodge of hid burden.

Section 6. Each initiate, in addition to all other fees or charges, each affiliate from a foreign jurisdiction and each duel member from a foreign jurisdiction shall be required to pay a sum that may vary from time to time as determined by the Grand Lodge to be applied to the usages of the Masonic Charity Foundation as directed by Grand Lodge.

Article 4 Amendments to the By-Laws

Any preposition to amend or repeal these By-Laws or any portion thereof, must be made in writing, signed by at least five (5) members in good standing, presented at a Regular Communication and lie over without debate until the next Regular Communication after it is published in the Trestleboard when a vote of the majority of members present in favor of such proposition shall be necessary for it's adoption.

Article 5 Worshipful Masters Charity Fund

Each year the Lodge shall designate one thousand (\$1000.00) dollars to the Worshipful Master's Charity Fund and in addition, the Secretary shall, upon receipt of monies collected for the Worshipful Master's Charity Fund at the Annual Installation, deposit the same in am account

designated for this purpose. The Worshipful Master may, at his discretion; direct payments of any and all funds in the account, provided said payment is used for charitable purposes. This money shall not be carried over to the next Masonic year.

Article 6 Committees

On the evening of the Annual Communication of Officers or the Installation of Officers, the incoming Worshipful Master shall appoint the following Standing Committees. Auditing, Masonic Education, Blood Bank, Sick and Visiting and Refreshment/Entertainment.

<u>Auditing</u>. A committee of three (3) members, not holding other office, whose duty it shall be to examine the books, accounts and reports of the Treasurer, Secretary and Trustees and report in writing upon the accuracy of the same at a Regular Communication after the reports of other Officer's and Trustees have been received at the second Communication in February.

Masonic Education A committee of three members, whose duty it shall be to see that all elected candidates are aided in Masonic education in a friendly and fraternal way through the three degrees, also to hold a class of instruction within one (1) month of having been raised to the third degree. The purpose of this informal meeting is to impart information that will enable the newly raised Brother to travel and visit in a confident and knowledgeable manner.

Masonic Blood Bank A Chairman or committee shall be established to coordinate the participation of the Lodge in scheduled blood drives and represent the Lodge to the Grand Lodge Blood Bank Committee.

<u>Sick and Visiting</u> A committee of two (2) or more members shall be formed, in addition to all Officer's of the Lodge, to report on the progress and status of sick Brethren and their families, send appropriate communications such as get well or sympathy cards to the sick and bereaved. Personal visits and phone calls are to be made when at all possible.

Refreshment A Chairman or committee shall be formed who' duty shall be to see that refreshments are made available to the Brethren after meetings or special events or at such times as designated by the Worshipful Master.

Entertainment A committee consisting of three (3) or more members shall be formed, whose duty it shall be to make arrangements in conjunction with the Worshipful Master for Ladies Night, the Annual Installation Banquet, Table Lodge or any other times or special events designated by the Worshipful Master.

Article 7 Sale, Acquisition, Transference or Lease of Real Estate or Property

Section 1. The purchase, lease, mortgage or sale of any real estate owned by or to be acquired by Laurel Lodge #237 F&AM shall not be made unless a resolution is drawn and approved by not less than seventy five (75%) of the members present. The vote shall take place at the next Regular Communication after the details of the transaction have been outlined in the Tressleboard.

Section 2. The transfer of Lodge funds from one (1) account to another shall be at the discretion of the Financial Trustee's and by permission of the Worshipful Master.

Section 3. All Past Masters who have received a Past Master's Jewel, must sign a form that promises, upon his death, that his estate will return said Past Master's Jewel to the Lodge. If Jewel is not returned, his estate will receive a bill for the amount of said Jewel. This signed form, will be given to the Head Financial Trustee, to be stored in the Lodge safety deposit box. The Worshipful Master has discretion in this matter. A request will be made by all the Past Master's to sign the form. This Article will take effect January 1, 2020

Article 8. Masonic Law


